Midtown Streetscape Design

DISCUSSION	<p>Eric Bosman from Urban Collage spoke to the group about his involvement with streetscape projects and shared his knowledge of funding sources and feasible designs along State Routes.</p> <ul style="list-style-type: none"> The City's zoning ordinances can get GDOT to grant a variance to their rules if the zoning ordinance (local laws) explicitly requires the streetscape. Transportation Enhancement (TE) Grants - \$100,000 - \$500,000 for pedestrian and bicycle projects http://www.fhwa.dot.gov/environment/te/guidance.htm A nice example of a median is the new 14th street bridge in Atlanta Medians are not permitted on State Routes greater than 35 mile per hour. SR 9 is mostly 45 mph There are other streetscape that look good and encourage pedestrian and bike use that do not have a median Design elements and themeing can be accomplish with different streets having a particular species of tree The key is to raise money through private public partnerships to do the improvements
